ORDER:

In the N.O.O 1st cited, orders were issued granting relaxation of qualification of I.T.I to the post of JLM for the appointment made under compassionate appointment subject to certain conditions.

2. As per the existing rules the maximum age prescribed for appointment of dependants of deceased employees is 25 years to the post of JLM.

3. In the T.O.O 2nd cited, the APTransco has informed that, during the discussions held with the Unions it was agreed to enhance the age to 30 years in respect of compassionate appointments of the dependants of the deceased employees to the category of JLM.

4. After careful consideration, the APNPDCL hereby orders that the age for appointment of the dependant of deceased employee on compassionate grounds, shall be 30 years for appointment to the post of Junior Lineman instead of 25 years.

5. The orders come into force from the date of issue of this order.
