Sub: APNPDCL - I.R. – Recruitment (2010-11) for the post of LDC-Cum-Computer Operator in APNPDCL on regular basis - Written Test conducted - Certificates verified - Ambiguity in confirming/validating the PGDCA/DCA certificates issued by certain Computer Institutions – Clarification on certain issues – Requested – Reg.

Ref: Notification, dated: 16-12-2010 issued by APNPDCL.

In the reference cited above, a notification was issued for filling up of LDC-Cum-Computer Operator posts in APNPDCL/ Warangal on regular basis with prescribed qualification of Degree and a certificate course of MS Office/Office Automation in Computers recognized by the Government of AP. Subsequently a written test was conducted on 23-01-2011 by JNTU/Hyderabad and as per the merit obtained by the candidates, they were called for certificate verification and accordingly the original certificates have been verified.

2. On verification of the certificates submitted by the candidates, it is observed that, on the Computer Certificates (i.e. PGDCA/DCA) issued by certain Computer Institutes, there is an ambiguity with regard to the recognition of such Institutes and on certain other issues. The details of institutes which have issued Computer Certificates to the candidates applied for the post are as below.

Whether the computer certificates issued by the above institutes are valid for securing employment in Government organization or to register such certificates in Employment exchange only

- ii. If such certificates are valid for securing employment in Government organization, is the DOE & T is monitoring and observing the proceedings and standards of such Institutes while conducting examinations and issuing certificates.
- iii. Please arrange to issue the details of all institutes which are recognized by the DOE & T, Hyderabad so far.
