ORDER:

In the meeting of CMD/APTransco and CMDs/Discoms held on 24-11-2008, the subject relating to service rendered during the contract period as regular service for various purposes without financial benefit in the cadres of AE, Sub-Engineer, JAO & LDC-Cum-Computer Operators was discussed in detail and a decision was taken favourably considering the service of contract period as regular service for the purpose of fixing seniority only, without monetary benefit and without pensionary benefits. Accordingly, orders were issued by the APTransco vide reference cited.

The above matter has been placed before the DISCOM Board and after careful consideration, the Northern Power Distribution Company of A.P Limited decided to count the services rendered under contract appointments in the cadres of Asst.Engineer, Sub-Engineer, Junior Accounts Officer & LDC-Cum-Computer Operator as regular service for the purpose of Seniority only, without any monetary benefits such as increments, notional pay fixation, leave benefits etc.

The Chief General Manager (HRD) and Superintending Engineers of APNPDCL are requested to take action accordingly duly obtaining an undertaking from the incumbents that they shall not claim any financial benefits whatsoever including any arrears and increments of pay etc, for that service consequent on giving credit to the contract service for the purpose of Seniority.
