ORDER:

APNPDCL in the N.O.O 1st cited read with N.O.O 10th cited, has issued orders granting relaxation of qualification of I.T.I to the post of Junior Lineman for the appointments made under compassionate appointment /Medical Invalidation subject to the condition that the candidate shall acquire the prescribed qualification within 7 years from the date of such appointment otherwise the commencement of probation shall be postponed till such time the said qualification is acquired. It was also ordered therein that the said appointments should be subject to fulfilling all other conditions stipulated from time to time.

2. In the reference 3rd cited read with N.O.O 5th and 7th cited, the APNPDCL has issued orders granting relaxation of qualification of I.T.I to the post of JLM under appointment by transfer from the categories of Office Sub-ordinate, Watchman and Sweeper-cum-Gardner subject to the conditions prescribed therein.

3. In the T.O.O 11th cited, the APTransco has issued orders that the commencement and completion of probation shall be declared to the Junior Lineman appointed on Compassionate Grounds/Medical Invalidation and Appointment by Transfer without I.T.I Qualification as per eligibility after acquisition of Graduation Qualification or any other Higher Qualification within 7 years from the date of joining as Junior Lineman. Further, it was ordered that the Intermediate Vocational Courses like EDAR, EWC & EW & SEA shall be considered in lieu of prescribed I.T.I qualification for appointment to the post of Junior Lineman under compassionate appointments/Medical

4. After careful consideration, the Northern Power Distribution Company of AP Limited hereby orders that the commencement and completion of probation shall be declared to the Junior Lineman appointed on Compassionate Grounds/Medical Invalidation and Appointment by Transfer without I.T.I qualification as per eligibility after acquisition of Graduation Qualification or any other Higher Qualification within 7 years from the date of joining as Junior Lineman.

5. APNPDCL also orders that the Intermediate Vocational Courses like EDAR, EWC & EW & SEA shall be considered in lieu of prescribed I.T.I qualification for appointment to the post of Junior Lineman under compassionate appointments/Medical Invalidation and Appointment by Transfer from the categories of Office Sub-ordinate, Watchman and Sweeper-cum-Gardner.

6. All other conditions mentioned in the NOOs shall remain unaltered/unchanged.
