ORDER:

In the reference 1st cited, reintroduction of Medical Scheme was formulated and certain guidelines were issued for reimbursement of medical charges to APNPDCL employees and their dependents/retired employees/dependents/family pensioners.

2. In the T.O.O 2nd cited, the APTransco has issued orders for modified Medical Scheme to the existing one, as issued in the T.O.O (Addl.Secy-Per) Ms.No. 301, Dt: 31-03-2009.

3. After careful consideration, the APNPDCL hereby issues the modified Medical Scheme orders to the existing one, issued in the reference 1st cited, as follows:

MODIFICATION:

The maximum ceiling limit of Rs. 2.00 lakhs is fixed for all the minor ailments/diseases **for life time with effective from 01-04-2009** for all Employees /Pensioners and their dependents/Family Pensioners other than the major ailments specified here under.

A maximum ceiling limit of Rs. 2.00 lakhs (Rupees two lakhs only) is fixed for each time and each ailment separately for different major ailments/ surgeries/ treatments i.e CABGS, Double valve replacement, Kidney Transplantation, Cancer, Neurosurgery, Aortic valve replacement, PTCA STENT be restricted to three spells for each of these diseases. Three spells means three surgeries for same ailment. This medical scheme, effective from 01-04-2011, is prospective till revised Medical Scheme announced by the Government for its Employees/ Pensioners.

In the reference 2nd cited, reintroduction of Medical Scheme was formulated and certain guidelines were issued for reimbursement of medical charges to APNPDCL Employees/Pensioners and their dependents/family pensioners. In the N.O.O 4th cited, orders were issued for Modified Medical Scheme to the existing one issued in the N.O.O 2nd cited.

2. The APTransco in the reference 5th cited, has issued further orders for extension of medical facility for all employees/pensioners and their dependents/family pensioners.

3. After careful consideration of certain issues of medical scheme, the following further orders are issued for extension of medical facility for all employees/pensioners and their dependents/family pensioners

In regard to

Cancer: In respect of cancer treatment, the cycle of Chemotherapy/Radiation therapy as recommended by the specialist doctor from the Govt./Empanelled corporate hospitals is considered for reimbursement as one spell limiting to Rs. 2.00 lakhs.

Kidney Transplantation/Dialysis:

a) 50% of the expenditure incurred towards purchase of medicines/injections who have undergone kidney transplantation and also for medicines/injections to be administered prior to each time under going dialysis is reimbursed not exceeding Rs. 4500/- P.M and this amount is not linked with the regular reimbursement ceiling limit.

b) Dialysis: Dialysis facility is provided on credit basis to the employees and their dependents as in patient in the recognized hospitals. The charges for providing the facility are limited to the CGHS rates for each sitting or package rates of recognised hospitals which ever is less. The charges are including for Dialysis, tubings and other disposals. This facility is not linked to eligibility of medical reimbursement charges and available to employees on rolls only.

4. These orders shall effective from 02-09-2011.
