**ORDER:**

In the N.O.O 2<sup>nd</sup> cited, orders were issued duly adopting the T.O.O (Addl.Secy-Per) Ms.No. 255, Dt: 19-02-08 reference 1<sup>st</sup> cited, that the borrowing company shall remit the Leave Salary contribution @ 11% per month of the pay actually drawn by the employee during the period of deputation and Pension Contribution @ 21.46% per month of the Pay + DA actually drawn by the employee or on the maximum of the time scale of the pay of the post held in APNPDCL at the time of deputation and during the period of deputation whichever is higher to the parent company irrespective of the class or grade to which the employee belongs with effect from 01-04-2006.

2. As per the final Actuarial valuation report submitted by the Hewitt Associates (India) Pvt.Ltd. received vide reference 3<sup>rd</sup> cited, the contribution rate assuming salary escalation rate as per Scenario-I to APNPDCL is 26.16%.

3. After careful consideration and keeping in view of the contribution rate assuming salary escalation rate as per Scenario-I to APNPDCL furnished in the final Actuarial valuation report submitted by the Hewitt Associates (India) Pvt. Ltd., the following amendment is issued to the N.O.O (CGM-HRD) Ms.No. 169, Dt: 05-09-08.

**AMENDMENT**

For the words 21.46% occurring at para 2 (i) against Pension contribution shall be read as **26.16 %** .

4. The other conditions in the N.O.O (CGM-HRD) Ms.No. 169, Dt: 05-09-08 shall remain unaltered.
